Resolution EC 21-05

Title: Authorization to Apply for U.S. Department of Justice Coordinated Tribal Assistance Solicitation Program Funding

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 32,000 citizens; and

WHEREAS, under Article X of the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, Tlingit & Haida has identified as a tribal priority the development and delivery of programs and services addressing tribal justice, tribal court, public safety, child welfare, and youth at-risk; and

WHEREAS, Tlingit & Haida is advised of the availability of funding through the U.S. Department of Justice, 2021 Coordinated Tribal Assistance Solicitation (CTAS) Program, for projects addressing tribal justice, tribal court, public safety, child welfare, and youth at-risk; and

WHEREAS, Tlingit & Haida intends to apply for up to \$3.3 million in funds from the U.S. Department of Justice, Coordinated Tribal Assistance Solicitation Program for projects up to five years, and such funding includes the full amount of Tlingit & Haida's federally approved indirect rate;

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska hereby authorizes the Tlingit & Haida President, or designee, to submit, negotiate, execute, and administer, any and all documents, including any subsequent amendments, that are required by the U.S. Department of Justice, 2021 CTAS Program, for granting funds to Tlingit & Haida for projects in: Purpose Area #1 Public Safety and Community Policing; Purpose Area #3 Tribal Justice Systems Program; Purpose Area #6 Children's Justice Act Partnerships for Indian Communities; Purpose Area #8 Juvenile Tribal Healing to Wellness Courts; and Purpose Area #9 Tribal Youth Program.

ADOPTED this 17th day of February 2021, by the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska, by a vote of 5 yeas, 0 nays, 0 abstentions and 1 absence.
