## Resolution EC 22-22

Title: Authorization to Apply for U.S. Department of Justice Tribal Victim Services Set-Aside Formula Grant Program Funding

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 33,000 citizens; and

WHEREAS, under Article X of the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, Tlingit & Haida is committed to providing services to Tribal citizens who are victims of crime; and

WHEREAS, the U.S. Department of Justice Office of Justice Programs Office for Victims of Crime has announced FY 2022 funding for the Tribal Victim Services Set-Aside Formula Grant Program to support the provision of victim services in American Indian and Alaska Native communities; and

WHEREAS, this funding can be used to provide a wide array of victim services including providing services and support to the family members of missing and murdered Indigenous relatives, offering support groups and/or individual counseling to adult survivors of childhood sexual abuse, and providing opportunities to participate in trauma-informed inpatient and outpatient substance abuse treatment and mental health counseling for survivors of domestic violence and sexual assault; and

WHEREAS, funding is allocated to tribes through discretionary administrative formula based on the Population Certifications submitted by tribes, and Tlingit & Haida has been allocated a maximum of \$663,204 in non-competitive funding; and

WHEREAS, Tlingit & Haida intends to apply for up to \$663,204 in non-competitive funds from the U.S. Department of Justice to provide victim services, and such funding includes the full amount of Tlingit & Haida's federally approved indirect rate;

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska hereby authorizes the Tlingit & Haida President, or designee, to submit, negotiate, execute, and administer any and all documents, including any subsequent amendments, that are required by the U.S. Department of Justice for granting funds to Tlingit & Haida under the Tribal Victim Services Set-Aside Formula Grant Program.

ADOPTED this 11<sup>th</sup> day of May 2022, by the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska, by a vote of 5 yeas, 0 nays, 0 abstentions and 1 absence.
