## Resolution EC 23-16

Title: Authorization to Carry Over Head Start Fiscal Year 2022 Funds

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 35,000 citizens; and

WHEREAS, under Article X of the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, Tlingit & Haida administers the Head Start program, whose purpose is to promote school readiness by enhancing the social, physical, and cognitive development of children; and

WHEREAS, Tlingit & Haida has over 40 years of experience serving children and families through Head Start, providing quality early childhood educational services that promote school readiness, grounded in a mission to respectfully nurture families and their children to grow, participate in life with confidence and awareness, and use their strengths to reach their full potential; and

WHEREAS, due to unforeseeable circumstances, Tlingit & Haida was unable to complete projects funded and slated for Fiscal Year (FY) 2022; and

WHEREAS, an amount up to \$1,800,000.00 in the Head Start Grant 90CI009960-6 was not expended in FY 2022; and

WHEREAS, Tlingit & Haida must submit a carryover request to the Office of Head Start for the unexpended funds from FY 2022; and

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska hereby authorizes the Tlingit & Haida President, or designee, to submit, negotiate, execute, and administer any and all documents, including any subsequent amendments, that are required by the Office of Head Start for granting the carryover request to Tlingit & Haida for the unexpended funds from FY 2022, and for managing such funds.

ADOPTED this 20<sup>th</sup> day of March 2023, by the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska, by a vote of 5 yeas, 0 nays, 0 abstentions and 1 absence.
