## Resolution EC 23-22

Title: Authorization to Request the Bureau of Indian Affairs to Add Routes to the National Tribal Transportation Facility Inventory Database

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 35,000 citizens; and

WHEREAS, under Article X of the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, Tlingit & Haida qualifies for services and benefits under the federal Tribal Transportation Program; and

WHEREAS, Tlingit & Haida has considered an area that encompasses its traditional and cultural use areas as well as boundaries connecting with adjacent communities when determining the route selection for the Tribe; and

WHEREAS, Tlingit & Haida has identified the project routes, identified in the table below, as a transportation project priority; and

WHEREAS, Tlingit & Haida would benefit from the addition by the Bureau of Indian Affairs (BIA) of Routes 2064, 2065, 2066, 2067, 2068, 2069, 2070, 2071, and 2072 into the BIA National Tribal Transportation Facility Inventory as a construction need;
