Resolution EC 23-49

Title: Authorization to Apply for U.S. Department of Agriculture Local Food Purchase Assistance Cooperative Agreement Program Grant

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 35,000 citizens; and

WHEREAS, under Article X of the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, promoting and advancing food security remains a priority and is critical to the health of our tribal citizens; and

WHEREAS, Tlingit & Haida's food security mission is to develop and supervise traditional food security initiatives through collaboration between tribal programs and with externals partners; and

WHEREAS, in pursuit of food security, Tlingit & Haida strives to reconnect and strengthen our deep and spiritual bond to the land by normalizing hunting, fishing, and gathering of our traditional foods and making them available to all tribal citizens; and

WHEREAS, the U.S. Department of Agriculture (USDA) Agricultural Marketing Service has announced its Indigenous Animals Harvesting and Meat Processing Grant Program; and

WHEREAS, Tlingit & Haida intends to apply for up to \$5 million in funds from the USDA for a three-year project, and such funding includes the full amount of Tlingit & Haida's federally approved indirect rate; and

WHEREAS, this funding could be used to provide support and program enhancements to Tlingit & Haida's Traditional Foods Program;

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska hereby authorizes the Tlingit & Haida President, or designee, to submit, negotiate, execute, and administer any and all documents, including any subsequent amendments, that are required by the U.S. Department of Agriculture for granting funds to Tlingit & Haida for the proposed project.

ADOPTED this 15th day of June 2023, by the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska, by a vote of 5 yeas, 0 nays, 0 abstentions and 1 absence.
