## Resolution EC 23-51

Title: Authorization to Enter into an Indian Self-Determination and Education Assistance Act 105(l) Lease with the U.S. Department of the Interior for Klawock Cooperative Association

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 35,000 citizens; and

WHEREAS, under Article X of the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, Tlingit & Haida has negotiated an Annual Funding Agreement pursuant to a Compact under Title IV of the Indian Self-Determination & Education Assistance Act (ISDEAA), also known as Public Law 93-638, as amended, codified at 25 U.S.C. §§ 5301 et seq., to assume the responsibilities of the U.S. Department of Interior, Bureau of Indian Affairs' (BIA) programs, functions, services, and activities (PFSAs) for the benefit of Tlingit & Haida and its compacted tribes; and

WHEREAS, Klawock Cooperative Association (KCA) is the federally recognized tribe for Klawock, Alaska, and joined a Compact under Title IV of ISDEAA with Tlingit & Haida; and

WHEREAS, Section 105(l) of the ISDEAA (25 CFR §§ 900.69-.70) provides that tribes carrying out federal functions under a self-governance compact may enter into lease agreements with the U.S. Department of Interior for facilities owned and leased by tribes to carry out PFSAs; and

WHEREAS, KCA owns or leases the following properties located in Klawock, Alaska:

- A. KCA Administrative Office Building 310 Bayview Blvd. Block 22 Lot 1-3 Klawock, AK 99925
- B. KCA Administrative Office Building 310 Bayview Blvd. Block 22 Lot 4-6 Klawock, AK 99925
- C. 310 Bayview Blvd. Block 22 Lot 7-8 Klawock, AK 99925, Enterprise 310 Bayview Blvd. Block 16 Lot 5-7 Klawock, AK 99925, Cannery

WHEREAS, the above-described properties are used for the administration and delivery of PFSAs under the Compact by KCA; and

WHEREAS, KCA will provide notice such that the start date for approved ISDEAA 105(l) leases for the above-described properties will be the date the request is submitted to the BIA; and

WHEREAS, KCA has determined that it would be in the Tribe's best interest to enter into ISDEAA 105(l) leases for the above-described property;

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska hereby authorizes the Tlingit & Haida President, or designee, to submit, negotiate, execute, and administer any and all documents, including any subsequent amendments, that are required by the U.S. Department of the Interior, Bureau of Indian Affairs for Klawock Cooperative Association's Indian Self-Determination & Education Assistance Act 105(1) leases under the Compact.

ADOPTED this 15<sup>th</sup> day of June 2023, by the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska, by a vote of 5 yeas, 0 nays, 0 abstentions and 1 absence.
